# "HUMAN RESOURCE MANAGEMENT IN CIVIL SERVICE AMID COVID-19: BEST PRACTICES AND SOLUTIONS"

**Background:** COVID-19 pandemic is one of the greatest challenges faced by governments around the world. It is a time the public sector plays a crucial role in responding, mitigating, and helping resolve the crisis. In this vein, the effectiveness of public administration is of primary importance.

Apparently, the pandemic launched a completely new reality, introduced drastic changes in the work of the civil service in many countries. The new reality is characterized by a change in targets and values, swift and effective government decision making, an emergency transition of business processes to a digital platform and agile planning.

Today, the civil service of most countries has switched to telecommuting arrangements. This is the first and unique experience for many civil service systems that remained supporters of the traditional bureaucratic form of organization. In turn, this led to specific changes in the civil service human resources management system including civil service rules for home-based work, wage subsidies, sick leaves, effective business continuity and self-management, teamwork, maintaining social interactions with colleagues, maintaining high levels of motivation and performance etc.

Consistent with its mission and with overall purpose to contribute to a global exchange of experiences, knowledge and best practices in applying innovations and finding best fit solutions aimed at improving the effectiveness of responses in the governance, civil service and public service delivery areas in the context of COVID 19, the Astana Civil Service Hub in partnership with the the Ministry of Personnel Management of the Republic of Korea, Agency of the Republic of Kazakhstan for Civil Service Affairs is organizing an online conference on "Human Resource Management in Civil Service amid COVID-19: Best Practices and Solutions".

**Objectives:** The conference aims to focus on a discussion of the latest developments, emerging challenges, as well as rapid solutions in Human Resource Management in civil service during COVID-19 induced crisis, including:

- sharing expertise, achievements and lessons learnt;
- look at progressive, effective and innovative tools in HRM;
