jointly organized by the Astana Civil Service Hub, State Examination Center of the Republic of Azerbaijan

September 14, 2021

Background. The outbreak of the global COVID-19 pandemic has changed the world – the way people think, act, and consider to be priorities in addition to the health implications and loss of life. For public administration, understanding what these new priorities are is crucial to better serve the people. Since the COVID-19 pandemic started, there were challenges in the implementation of planned reforms in public administration within the region too. In a show of courageous response, in many countries, civil servants have been quick to adapt and re-adjust the way in which services are delivered so as to minimize the negative impact of the pandemic on individuals and society.

In this context, sharing experiences, good practices, and lessons learned given the current challenges is important for the countries of the region and beyond. For this reason, the Astana Civil Service Hub (ACSH) and the State Examination Center of the Republic of Azerbaijan (SEC) plan to invite representatives of the academic community and public administration practitioners to participate in an online event in order to discuss aspects of good practices nailed during the COVID-19 pandemic from both an academic and a practical point of view.

The Conference is aimed at the provision of a comprehensive overview and analysis of current reforms and trends in the field of civil service in the ACSH participating countries, as well as best practices that are important to build an effective and sustainable public administration system.

Participants: representatives of authorized bodies of Hub participating countries and other countries, professional organizations and associations, academies, universities and institutes, as well as international organizations.

The main **expected outcomes** of the event are:

- To exchange experience, best practices, and lessons learned that would serve to guide practitioners in the field of effective public administration.
- To exchange experience in the implementation of civil service reforms aimed at finding common solutions with restricted opportunities.
- To highlight key areas that could be the focus of future public administration reforms.
- To identify the most pressing challenges and key problems in public administration.
- To develop partnerships in order to generate knowledge on the issues at hand that may be beneficial to all.
